August 2022 Newsletter

A lot of things have been happening since the new year at the lake, so this newsletter is designed to share this with lake association members. GENERAL MEMBER MEETING AND BRAT SOCIAL HOUR

General Annual meeting is scheduled for August 27, 2022 and will be at May's Bar. We will do a 1:00 Brat social hour prior to the 2:00 general meeting.

AERATOR STARTUP and RESULTS

The aerator began running Jan 1 after assoc. members installed the safety barrier, and the system ran 24 hours/day until April 26. As part of the grant agreement, oxygen data was also collected twice during the winter. A review of the data was very encouraging when compared to that collected by Flambeau Engineering 5 years prior. The previous work showed oxygen levels close to 0, whereas ours showed values of 3-5%. That may not seem like much, but levels we recorded are in the range needed for fish survival. Please note that the aeration system will NOT prevent all fish kills in the future. The DNR said a lake the size of Little Rice would need at least 4 aeration systems to prevent all fish kills. However, what the lake assoc. installed should prevent future major fish kills and allow for quicker recovery by saving a significant number of fish for repopulation. The aerator will be started up again this winter and the barrier will once again be installed. If you want to help with barrier install/pick up, or oxygen data collection, please contact a LRLA board member - all help is encouraged and needed!

FISH NEWS

After ice out, Steve Motiff kayaked the lake picking up barrier poles and saw 150-200 dead fish. On June 1, the DNR placed 5 fish traps in spawning areas for a fish population study. The DNR fish biologist Greg Matzke was contacted about the survey, and he was told about the fish kill Steve saw. Greg said he would have expected a much larger fish kill due to thickness of ice and length of coverage if the aerator had not been

installed. He said there's no doubt the aeration system prevented a much larger fish kill and gave kudos to the lake association for installing the system.

Marty Thyssen saw a fish kill of several hundred fish on the north side of the lake in mid-June. Greg was contacted and he said a fish kill that time of the year is pretty common as the fish are stressed at the end of the spawning season and succumb to that stress.

Once the results of the fish survey are compiled, the results will be sent to the lake assoc. and will be shared with members. However, Greg did say the results were VERY encouraging and said the number of spawners was about twice that of any other local lakes.

BOAT PARADE

As planned, the annual boat parade was held Sunday July 3. There was a turnout of 8 boats loaded with folks armed with water guns enjoying the great weather - even if the water was cold.

VOLUNTEER NEWS

There was a good turnout of LRLA volunteers for the Brush Run. We had a total of 13 members volunteer and most worked the margarita/Bloody Mary bar for about 5 hour stints at different times over the weekend. The money to be paid to the lake association should help immensely in helping to offset running costs of the aeration system. The next planned volunteer opportunity is for the off-road championships Sept 1-4. Please join us if you can – the work is easy and it's a great way to mingle and get to know assoc. members.
