

# March 2023 Newsletter

### AERATOR

Start-up for the aerator this winter was on Dec 31, 2022 – a month earlier than last season. The barrier was installed by Jay Barta, Mike Braunreiter, Chris Dockry, Steve Motiff, Marty Thyssen, and Pat Larscheid on the same day as start-up. As part of the agreement for aeration funding by the DNR, Steve Motiff and Dave O'Bright collected oxygen readings on 1/10 and 2/13. The data showed there was a significant drop in oxygen between the two dates – from an average of 20-30% down to an average around 2-5%. Steve and Dave plan on recording oxygen one more time in March. Once the lake opens and the barrier falls in, the barrier will have to be retrieved and stored away for the summer. Anybody that wants to get involved in ANY of the aeration system upkeep, please contact anybody on the LRLA board. ALL help is greatly appreciated!

COMMENTS on dissolved oxygen readings:

- 1. Dissolved oxygen readings need to be greater than 6% for fish to survive.
- 2. The oxygen readings were recorded in a total of 12 holes radiating out from the aeration system in three lines. The closest readings to the open water were about 250' away for safety reasons. There is no doubt the oxygen values are much higher below the open water created by the aeration system.
- 3. An email was sent to Greg Matzke (DNR fish biologist for Forest County) after the second data set was collected to get his input as to why he thought oxygen levels dropped so quickly. He said oxygen values are greatly impacted by plant growth during the summer: the more plant growth, the faster the oxygen will be depleted in the winter due to decaying plants. Therefore, summers with more plant growth will result in oxygen levels dropping faster. Greg also thought there should NOT be a large fish kill this year because the ice is about 10" thinner on average this year and he's anticipating and earlier ice breakup.
- 4. The dissolved oxygen data is available for anybody interested in getting a copy of it.

A fluorescent throw ring attached to a rope was purchased by the lake association and hung on a large tree near the aeration system. The board of directors agreed to the purchase for potential emergency use during the winter season's open ice.

#### **DNR WATER SURFACE GRANT APPLICATION**

On November 15<sup>th</sup>, 2022, the Wisconsin Department of Natural Resources (DNR) received our applications for Surface Water grants. In total, applicants submitted 446 applications requesting over \$7.2 million. The decision-making process was a difficult one, with only \$6.5 million in state funding available. As a result, the DNR was not able to fund all the deserving projects that were proposed. I regret to inform you that our application was not selected for funding this year. We will be looking into the Recreational Boating Facilities Navigational Aids Grant to see if this is something that would benefit our members.
